

Klettafjalla Board Meeting May 14, 2012

Board members present on call: Linda McLaughlin, Karen Olson, Coralie Denmeade, and Lynne Fickett

Treasurers Report: Karen reported the treasury the same as last time plus 1 \$15.00 new member fee.

Rocky Mountain Horse Expo: Coralie has sent all her receipts from the Expo to Kari at USIHC with copies to Karen for reimbursement. Karen will also send Coralie the \$100.00 the club agreed to send to her.

Coralie reported that our breed and drill team presentation both evenings are becoming a favorite at the Expo; and there was a much greater interest in our breed this year than in years past.

Logo Items: From the company Coralie uses, to begin there is a set-up fee of approximately \$35.00, then any items ordered from their catalog cost an additional \$2.00 for the logo to be added.
